BIDS AND AWARDS COMMITTEE
RESOLUTION NO. 033-2022
(RQ Nos. 03-010P, 03-011P, 03-012P, 03-013P and 03-014P;
Submersible Pumps and Motors)

WHEREAS, the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act (RA) No. 9184, conducted the biddings for the procurement of various submersible pumps and motors, with the required specifications under Request for Quotation (RQ) Nos. 03-010P, 03-011P, 03-012P, 03-013P and 03-014P all dated 11 March 2022, under a two-envelope system of bidding;

WHEREAS, **LJ INDUSTRIAL FABRICATION, INC.** and **KEYLARGO INDUSTRIAL SALES** submitted their bids and during the opening of its technical bids on 06 April 2022, it was determined that **KEYLARGO INDUSTRIAL SALES** submitted complete documentary requirements from all of its principal suppliers. As for the bid of **LJ INDUSTRIAL FABRICATION, INC.**, it was determined that the submitted ISO Certificate issued to Franklin Electric is only valid until 28 February 2022, thus, its bids for the subject RQs were rated and declared as "failed";

WHEREAS, in a letter dated 24 May 2022 and sent through electronic mail on 25 May 2022, the BWD-BAC informed **LJ INDUSTRIAL FABRICATION, INC.** of its failed bids and was given a period of three (3) calendar days to file its request for reconsideration;

WHEREAS, on 26 May 2022, the BWD-BAC received from **LJ INDUSTRIAL FABRICATION, INC.**'s its request for reconsideration for the five (5) RQs with an attached letter from Franklin Electric dated 25 May 2022 stating that the latter was not able to issue to **LJ INDUSTRIAL FABRICATION, INC.** the updated ISO Certification due to some delays in their system. **LJ INDUSTRIAL FABRICATION, INC.** likewise submitted ISO Certificates of Franklin Electric USA and Mexico valid until 28 February 2025 and 10 April 2024, respectively;

WHEREAS, pursuant to the 2016 Revised Implementing Rules and Regulations of RA No. 9184, a bidder shall not be allowed to submit additional documents to correct any defects in the bid submitted once the deadline for the submission and receipt of bids had already lapsed;

NOW THEREFORE, on motion duly seconded, be it

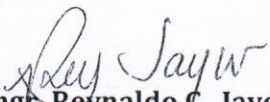
RESOLVED, as it hereby resolved, to deny with finality the request for reconsideration filed by **LJ INDUSTRIAL FABRICATION, INC.** dated 26 May 2022 considering that its bids were already opened on 06 April 2022, and submission of additional documents, such as the newly submitted valid ISO Certificates of Franklin Electric Company, Inc. for its USA and Mexico factories, could no longer be taken into consideration;

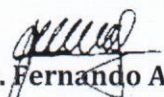

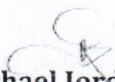
RESOLVED FINALLY, to endorse the bids of **KEYLARGO INDUSTRIAL SALES** to the Technical Working Group for evaluation.

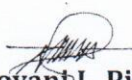
