BIDS AND AWARDS COMMITTEE RESOLUTION NO. 067-2022

(2022-2023 Security Services)

WHEREAS, the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act (RA) No. 9184, conducted the bidding for the procurement of Security Services (2022 to 2023) for Baguio Water District, under a two-envelope system of bidding, commencing with the posting of the Invitation to Bid at PhilGEPS and BWD websites;

WHEREAS, the approved budget for the contract (ABC) is Php18,533,696.64;

WHEREAS, during the submission of bids on September 16, 2022, AGILEX SECURITY AGENCY, PRIMUS PRAESIDIO PRIVATE SECURITY SERVICES INC. and SIDEKICK FORCE INVESTIGATION AND SECURITY SERVICES, INC. submitted their bids, and upon bid opening, it was determined that they initially complied with the documentary requirements; thus, their financial proposals were opened, and their bids as read are as follows:

WHEREAS, after careful evaluation and consideration, the bids of AGILEX SECURITY AGENCY and PRIMUS PRAESIDIO PRIVATE SECURITY SERVICES INC. were rated and declared as "disqualified" for being non-compliant with and non-responsive to the requirements and conditions specified in the Bidding Documents;

WHEREAS, having been found to have submitted complete documents, a recommendation for award to SIDEKICK FORCE INVESTIGATION AND SECURITY SERVICES, INC. is hereby submitted to the General Manager;

NOW THEREFORE, on motion duly seconded, be it

RESOLVED, as it is hereby resolved, to recommend the award of the procurement of BWD security services for 2022 to 2023 to **SIDEKICK FORCE INVESTIGATION AND SECURITY SERVICES**, **INC**. in the contract amount of **EIGHTEEN MILLION FOUR HUNDRED FIFTY-SEVEN THOUSAND SIX HUNDRED EIGHTY EIGHT PESOS AND 72/100** (Php18,457,688.72) for being the lone calculated responsive bidder;

RESOLVED FURTHER, to inform **AGILEX SECURITY AGENCY** and **PRIMUS PRAESIDIO PRIVATE SECURITY SERVICES INC.** of their non-compliance pursuant to RA 9184.
