INVITATION TO BID

SUPPLY, INSTALLATION AND COMMISSIONING OF WIRELESS SUPERVISORY CONTROL AND DATA ACQUISITION (SCADA) SYSTEM AT DIFFERENT BAGUIO WATER DISTRICT (BWD) PUMPING STATIONS

- 1. The BAGUIO WATER DISTRICT (BWD), through the BWD 2022 Corporate Operating Budget, intends to apply the sum of **FORTY-NINE MILLION NINE HUNDRED SEVENTY-THREE THOUSAND THREE HUNDRED PESOS (PHP49,973,300.00)**, inclusive of all applicable taxes, being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply, Installation and Commissioning of Wireless Supervisory Control and Data Acquisition (SCADA) System at Different Baguio Water District (BWD) Pumping Stations. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The BAGUIO WATER DISTRICT (BWD), through its Bids and Awards Committee (BAC), now invites bids for the Supply, Installation and Commissioning of Wireless Supervisory Control and Data Acquisition (SCADA) System at Different Baguio Water District (BWD) Pumping Stations. Contract duration is two hundred seventy-five (275) days. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to this bidding. The description of an eligible bidder is contained in the Volume 1 of the Bidding Documents particularly, in Section I (Instruction to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 Revised IRR of RA No. 9184.
- 4. Prospective Bidders may obtain further information from the BWD-BAC and inspect the Bidding Documents at the address given below during regular office hours (8:00 a.m. to 5:00 p.m.).
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on March 17, 2023 to April 10, 2023 weekdays only (8:00 AM 5:00 PM) and on April 11, 2023 (8:00 AM 10:00 AM) from the given address below and upon payment of the applicable non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php25,000.00. The BWD-BAC shall allow the bidder to present its proof of payment for the bidding documents. It may be presented in person or through electronic mail.
 - The Bidding Documents may also be downloaded free of charge from the websites of the Philippine Government Electronic Procurement System (PhilGEPS) and BWD, provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.
- 6. The BWD-BAC will hold a Pre-Bid Conference on **March 27, 2023, 9:00 AM** through video conferencing via Zoom Application with Meeting ID: 452 718 8447 and Password: 9Buvqr, which shall be open to prospective bidders.

7. Sealed Bids must be duly received by the BWD-BAC Secretariat through manual submission at the office address indicated below on or before **April 11, 2023 not later than 10:00 AM**. Late bids shall not be accepted.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.
- 9. Bid opening shall be on **April 11, 2023 at 10:00 AM** via video conferencing using Zoom Application, and details will be sent to the bidder's respective email address. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. BWD assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.
- 11. BWD reserves the right to accept or reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
