WHEREAS, the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act No. (RA) 9184, conducted the bidding for the project: Proposed Drilling of Ramsey 2 Parallel Production Well;

WHEREAS, by virtue of BAC Resolution No. 088-2023, the request for reconsideration of **P-RAYMUNDO CONSTRUCTION** was denied for lack of merit and the period within which to file a protest in accordance with the provisions of RA 9184, having lapsed without any protest received, the declaration of the bidder's "failed" rating is hereby declared final;

WHEREAS, the financial bid of the lone complying bidder was thereafter opened and it was determined that the submitted financial bid did not exceed the Approved Budget for the Contract;
