WHEREAS, the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act No. (RA) 9184, conducted the bidding for the project: *Proposed Deepening of Kadaclan Production Well from 150 meters to 200 meters*;

WHEREAS, the Approved Budget for the Contract is Php2,510,852.60;

WHEREAS, only JASHV CONSTRUCTION AND SUPPLY submitted its bid and during the opening of the technical bids on 13 December 2023, it was determined that the technical proposal of the lone bidder was rated "passed" for having submitted complete documentary requirements;

WHEREAS, the financial bid of the lone complying bidder was thereafter opened and it was determined that the submitted financial bid did not exceed the Approved Budget for the Contract;



NOW THEREFORE, on motion duly seconded, be it






