



Water Meter Inserts and Air Release Valves

WHEREAS, the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act (RA) No. 9184 and its Revised Implementing Rules and Regulations, conducted the bidding for the procurement of the following, all with required specifications under RQ 11-193P-B/201P-B, dated 10 November 2023, under a two-envelope system of bidding but not to be awarded on a one-lot basis and with approved budget unit costs of:

WHEREAS, only **FANM ENTERPRISES, INC.** submitted its bids and during the opening of the technical bids on 29 November 2023, it was determined that the lone bidder submitted complete documentary requirements thus, its technical bid was rated "passed;"

WHEREAS, the technical proposal the lone bidder was endorsed to the Technical Working Group (TWG) for evaluation;

WHEREAS, on 20 December 2023, the technical bid of **FANM ENTERPRISES, INC.** for the water meter inserts and the 2" air release valves were rated by the TWG as "complying" while its offer for the 1" air release valve was rated "non-complying" as the offered item did not meet the required dimensions and weight as stated in RQ 11-193P-B/201P-B;

WHEREAS, its financial bids were opened and the bids as read and calculated are as follows:
