WHEREAS, the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act No. (RA) 9184, conducted the bidding for the project: *Proposed Drilling of Stage 2 Production Well*;

WHEREAS, the Approved Budget for the Contract is Php8,144,104.72;

WHEREAS, only **LHS DRILLING ENTERPRISES** submitted its bids and during the opening of the technical bids on 10 January 2024, it was determined that the lone bidder submitted complete documentary requirements thus, the bidder was rated "passed;"

WHEREAS, the bidder's technical proposal was endorsed to the Technical Working Group (TWG) for evaluation;

WHEREAS, on 22 January 2024, the technical bid of **LHS DRILLING ENTERPRISES** was rated by the TWG as "complying";

WHEREAS, the financial bid of the lone complying bidder is determined complying as it did not exceed the Approved Budget for the Contract:





NOW THEREFORE, on motion duly seconded, be it


