## INVITATION TO BID

### PROPOSED DRILLING OF KISAD PARALLEL PRODUCTION WELL

1. The BAGUIO WATER DISTRICT (BWD), through the BWD 2024 Corporate Operating Budget, intends to apply the sum of **NINE MILLION TWO HUNDRED THIRTY-NINE THOUSAND SIX HUNDRED FIFTEEN PESOS AND 20/100 (PHP9,239,615.20)**, inclusive of all applicable taxes, being the Approved Budget for the Contract (ABC) for payments under the contract *Proposed Drilling of Kisad Parallel Production Well*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The BAGUIO WATER DISTRICT, through its Bids and Awards Committee (BAC), now invites bids for the *Proposed Drilling of Kisad Parallel Production Well*. **The contract duration is ninety-seven (97) calendar days.** Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to this bidding. The description of an eligible bidder is contained in Volume 1 of the Bidding Documents particularly, in Section I (Instruction to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. (RA) 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 Revised IRR of RA 9184.

4. Prospective Bidders may obtain further information from the BWD-BAC and inspect the Bidding Documents at the address given below during regular office hours (8:00 AM to 5:00 PM).
5. A complete set of Bidding Documents may be acquired by interested Bidders on **March 25, 2024 to April 14, 2024, on weekdays only (8:00 AM - 5:00 PM)** except on *Holidays*, and on **April 15, 2024 (8:00 AM - 10:00 AM)** from the given address below and upon payment of the applicable non-refundable fee for the Bidding Documents in the amount of Php10,000.00 according to the latest Guidelines issued by the GPPB.


The BWD-BAC shall allow the bidder to present its proof of payment for the bidding documents. The proof may be presented in person or may be sent through electronic mail.

The Bidding Documents may also be downloaded free of charge from the websites of the Philippine Government Electronic Procurement System (PhilGEPS) and BWD provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.


6. The BWD-BAC will hold a Pre-Bid Conference on **April 2, 2024 at 9:00 AM** through video conferencing *via* Zoom Application with Meeting ID: 452 718 8447 and Password: 9Buvqr, which shall be open to prospective bidders.
7. Sealed Bids must be duly received by the BWD-BAC Secretariat through manual submission at the office address indicated below on or before **April 15, 2024 not later than 10:00 AM**. Late bids shall not be accepted.

9. Bid opening shall be on **April 15, 2024 at 10:00 AM** *via* video conferencing using Zoom Application, and details will be sent to the bidder's respective email address. Bids will be opened in the presence of the participating bidders' representatives who choose to attend the activity.
10. BWD assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.

BWD reserves the right to accept or reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA 9184, without thereby incurring any liability to the affected bidder or bidders.
