-For bidders who have principal foreign suppliers, the BWD-BAC shall accept an Apostilled Certificate of Authorized Distributorship or Dealership issued by a competent authority of the host government in lieu of the Certificate of Authorized Distributorship or Dealership (with red ribbon), except for non-contracting countries to the Apostille Convention, which still require the red ribbon requirement.

-For locally produced or manufactured products, only a certificate of Authorized Distributorship or Dealership without a red ribbon is required, if applicable.

f) ISO Certificate issued to the principal supplier or participating bidder for the offered material or equipment brand name (if none has been submitted to the BAC in its Accreditation);

g) International Certificate of Warranty
