BIDS AND AWARDS COMMITTEE RESOLUTION NO. 097-2024

Request for Quotation (RQ) No. 04-070P: Liquid Gas Chlorine

WHEREAS, the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act (RA) No. 9184, conducted the bidding for the procurement of 60 cylinders of liquid gas chlorine, with required specifications under RQ No. 04-070P, dated 18 April 2024, under a two-envelope system of bidding;

WHEREAS, the approved budget cost is Php10,500.00/cylinder;

WHEREAS, only MABUHAY VINYL CORPORATION submitted its bids and during the opening of the technical bid on 15 May 2024, it was determined that the lone bidder submitted complete documentary requirements; thus, its technical proposal was rated "passed";

WHEREAS, the technical proposal of the lone bidder was endorsed to the Technical Working Group (TWG) for evaluation, and on 23 May 2024 the TWG rated the offer of **MABUHAY VINYL CORPORATION** as "complying";

WHEREAS, the financial bid of MABUHAY VINYL CORPORATION was opened and the bids as read and calculated are as follows:
