Proposed Drilling of Happy Glen Parallel Production Well

WHEREAS, the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act (RA) No. 9184, conducted the bidding for the project: *Proposed Drilling of Happy Glen Parallel Production Well;*

WHEREAS, by virtue of BAC Resolution No. 089-2024, the request for reconsideration of **PACERS TRADING AND SERVICES** was denied for lack of merit and the period within which to file a protest in accordance with the provisions of RA No. 9184, having lapsed without any protest received, the declaration of the bidder's "*failed*" rating is hereby declared final;

WHEREAS, the financial bid of the lone complying bidder, **JASHV CONSTRUCTION AND SUPPLY**, was determined complying as it did not exceed the Approved Budget for the Contract (ABC):

RESOLVED, as it is hereby resolved, to recommend to the Head of the Procuring Entity awarding the project: *Proposed Drilling of Happy Glen Parallel Production Well* to **JASHV CONSTRUCTION AND SUPPLY** in the amount of Nine Million Six Hundred Ninety-Nine Thousand One Hundred Twenty-Seven Pesos and Thirty-Seven Centavos (Php9,699,127.37), inclusive of all government taxes, for being the lone calculated responsive bidder.

RESOLVED FURTHER, to direct the BAC Secretariat to return the sealed financial bid of **PACERS TRADING AND SERVICES**.
