

BIDS AND AWARDS COMMITTEE
RESOLUTION NO. 104-2024
Proposed Drilling of Irisville Subdivision Production Well

WHEREAS, the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act (RA) No. 9184, conducted the bidding for the project: *Proposed Drilling of Irisville Subdivision Production Well*;

WHEREAS, the approved budget for the contract is Php9,822,973.65;

WHEREAS, **DOWSERS TREND CONSTRUCTION** and **LHS DRILLING ENTERPRISES** submitted their bids and during the opening of the technical proposals on 24 April 2024, it was determined that both bidders submitted complete documentary requirements, thus, their bids were rated “initially passed”;

WHEREAS, the technical proposals of **DOWSERS TREND CONSTRUCTION** and **LHS DRILLING ENTERPRISES** were endorsed to the Technical Working Group (TWG) for evaluation. During evaluation, the TWG was forewarned by the Municipality of Burgos stating that **DOWSERS TREND CONSTRUCTION** was awarded a project but was not completed due to the latter’s fault or negligence. The BWD-BAC confirmed the said information through a letter which was verified by the Municipality of Burgos, Ilocos Sur. Further, equipment verification was conducted on 02 and 23 May 2024. The TWG noted that the drilling rig and compressor are not at the project site but at another site outside Baguio City.

WHEREAS, on 30 May 2024, **DOWSERS TREND CONSTRUCTION** was informed through a letter of its disqualified bid and was given three (3) calendar days upon receipt of the said letter to file its request for reconsideration. However, the period granted has already lapsed and no request for reconsideration was received by the BWD-BAC. Thus, its “non-complying” rating became final; *(A copy of the letter is hereto attached as Annex A)*

WHEREAS, the technical proposal of **LHS DRILLING ENTERPRISES** was rated by the TWG as “complying”;

WHEREAS, on 14 June 2024, the financial bid of **LHS DRILLING ENTERPRISES** was determined complying as it did not exceed the Approved Budget for the Contract (ABC):

WHEREAS, upon completion of the post-qualification of **LHS DRILLING ENTERPRISES**, the technical and financial bids were rated “post-qualified” and the bidder is hereby declared the lone calculated responsive bidder;

NOW THEREFORE, on motion duly seconded, be it

RESOLVED, as it is hereby resolved, to recommend to the Head of the Procuring Entity awarding the project: *Proposed Drilling of Irisville Subdivision Production Well* to **LHS DRILLING ENTERPRISES** in the amount of Nine Million Eight Hundred Seventeen Thousand Seven Hundred Sixty-Five Pesos and Fifty-One Centavos (Php9,817,765.51), inclusive of all government taxes, for being the lone calculated responsive bidder.

RESOLVED FURTHER, to direct the BAC Secretariat to return the sealed financial bid of **DOWSERS TREND CONSTRUCTION**.
