

BIDS AND AWARDS COMMITTEE
RESOLUTION NO. 108-2024
Proposed Drilling of Ciudad Grande Phase 2 Subdivision Production Well

WHEREAS, the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act (RA) No. 9184, conducted the bidding for project: *Proposed Drilling of Ciudad Grande Phase 2 Subdivision Production Well*;

WHEREAS, the approved budget cost for the contract (ABC) is Php9,197,104.22;

WHEREAS, **LHS DRILLING ENTERPRISES** and **ROCKWELL CONSTRUCTION AND SUPPLY** submitted their bids and during the opening of the technical proposals on 03 June 2024, it was determined that both bidders submitted complete documentary requirements, thus, their bids were rated “initially passed”;

WHEREAS, on 14 June 2024, the financial bids of **LHS DRILLING ENTERPRISES** and **ROCKWELL CONSTRUCTION AND SUPPLY** were determined complying as it did not exceed the ABC:

WHEREAS, the technical proposals of **LHS DRILLING ENTERPRISES** and **ROCKWELL CONSTRUCTION AND SUPPLY** were endorsed to the Technical Working Group (TWG) for evaluation. During the evaluation, it was determined that **ROCKWELL CONSTRUCTION AND SUPPLY** did not submit a Certificate of Well Driller Registration issued by the National Water Resources Board (NWRB);

WHEREAS, on 04 July 2024, **ROCKWELL CONSTRUCTION AND SUPPLY** was informed through a letter to submit an updated and valid Certificate within five (5) calendar days upon receipt of the said letter. However, the period granted has already lapsed and no response was received by the BWD-BAC;

WHEREAS, upon completion of the post-qualification of **LHS DRILLING ENTERPRISES**, the technical and financial bids were rated “post-qualified” and the bidder is hereby declared as the second lowest complying responsive bidder;

NOW THEREFORE, on motion duly seconded, be it

RESOLVED, as it is hereby resolved, to recommend to the Head of the Procuring Entity awarding the project: *Proposed Drilling of Ciudad Grande Phase 2 Subdivision Production Well* to **LHS DRILLING ENTERPRISES** in the amount of Nine Million One Hundred Ninety-Two Thousand Two Hundred Forty-Four Pesos and Four Centavos (Php9,192,244.04), inclusive of all government taxes, for being the second lowest complying responsive bidder.

RESOLVED FURTHER, to inform **ROCKWELL CONSTRUCTION AND SUPPLY** of its post-disqualification and the award of the project to the 2nd lowest complying bidder.
