Solicitation Number No. 010-2024 (P)
Proposed Drilling of Purok 2 Irisan Production Well

WHEREAS, the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act (RA) No. 9184, conducted the bidding for the project: *Proposed Drilling of Purok 2 Irisan Production Well*, with required scope of work and specifications under Solicitation No. 010-2024 (P) dated 08 July 2024;

WHEREAS, the approved budget cost for the contract (ABC) is Php9,720,474.69;

WHEREAS, JASHV CONSTRUCTION AND SUPPLY and LHS DRILLING ENTERPRISES submitted their bids and during the opening of the technical bids on 27 August 2024, it was determined that the bidders submitted complete documentary requirements; thus, their bids were rated “*passed*”;

WHEREAS, upon evaluation by the Technical Working Group of the offers of the bidders, it was determined that the bidders submitted complying offers; thus, their financial bids were opened on 10 September 2024 and the bids as read and calculated are as follows:

WHEREAS, upon post-qualification, careful examination, validation, and verification of all the documents submitted by and of the financial bids of the complying bidders, **JASHV CONSTRUCTION AND SUPPLY** was rated “*post-qualified*”; thus, its financial bid is determined to be the lowest calculated responsive bid;

NOW THEREFORE, on motion duly seconded, be it

RESOLVED, as it is hereby resolved, to recommend to the Head of the Procuring Entity (HoPE) awarding the project: *Proposed Drilling of Purok 2 Irisan Production Well* to **JASHV CONSTRUCTION AND SUPPLY** in the amount of Nine Million Seven Hundred Fifteen Thousand Four Hundred Fifty-Seven Pesos and Seventy Centavos (Php9,715,457.70), inclusive of all government taxes, for being the lowest calculated responsive bidder.
