Proposed Drilling of Buyog 2 Production Well

WHEREAS, the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act (RA) No. 9184, conducted the bidding for the project: *Proposed Drilling of Buyog 2 Production Well*, with required scope of work and specifications under Solicitation No. 012-2024 (P) dated 08 July 2024;

WHEREAS, the approved budget cost for the contract (ABC) is Php8,794,837.84;

WHEREAS, JASHV CONSTRUCTION AND SUPPLY and **LHS DRILLING ENTERPRISES** submitted their bids and during the opening of the technical bids on 27 August 2024, it was determined that the bidders submitted complete documentary requirements; thus, their bids were rated *"passed"*;

WHEREAS, upon evaluation by the Technical Working Group of the offers of the bidders, it was determined that the bidders submitted complying offers; thus, their financial bids were opened on 10 September 2024 and the bids as read and calculated are as follows:

NOW THEREFORE, on motion duly seconded, be it

RESOLVED, as it is hereby resolved, to recommend to the Head of the Procuring Entity (HoPE) awarding the project: *Proposed Drilling of Buyog 2 Production Well* to **LHS DRILLING ENTERPRISES** in the amount of Eight Million Seven Hundred Eighty-Nine Thousand Eight Hundred Seventeen Pesos and Three Centavos (Php8,789,817.03), inclusive of all government taxes, for being the lowest calculated responsive bidder.
