## BIDS AND AWARDS COMMITTEE RESOLUTION NO. 145-2024

Proposed Deepening of Montinola Production Well from 150M to 200M

**WHEREAS,** the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act (RA) No. 9184, conducted the bidding for the project: *Proposed Deepening of Montinola Production Well from 150M to 200M*, with required scope of work and specifications under Solicitation No. 013-2024 (P) dated 08 July 2024;

WHEREAS, the approved budget cost for the contract (ABC) is Php2,643,360.40;

WHEREAS, JASHV CONSTRUCTION AND SUPPLY and LHS DRILLING ENTERPRISES submitted their bids and during the opening of the technical bids on 27 August 2024, it was determined that the bidders submitted complete documentary requirements; thus, their bids were rated "passed";

**WHEREAS**, upon evaluation by the Technical Working Group of the offers of the bidders, it was determined that the bidders submitted complying offers; thus, their financial bids were opened on 10 September 2024 and the bids as read and calculated are as follows:

**RESOLVED,** as it is hereby resolved, to recommend to the Head of the Procuring Entity (HoPE) awarding the project: *Proposed Deepening of Montinola Production Well from 150M to 200M* to **LHS DRILLING ENTERPRISES** in the amount of Two Million Six Hundred Thirty-Eight Thousand One Hundred Thirty-Four Pesos and Six Centavos (Php2,638,134.06), inclusive of all government taxes, for being the lowest calculated responsive bidder.
