WHEREAS, the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act (RA) No. 9184, conducted the bidding for the project: *Proposed Drilling of Old Lucban 2 Production Well*, with required scope of work and specifications under Solicitation No. 014-2024 (P) dated 08 July 2024;

WHEREAS, the approved budget cost for the contract (ABC) is Php9,185,224.89;

WHEREAS, only **MACROTRADE RESOURCES INC.** submitted its bids and during the opening of the technical bids on 27 August 2024, it was determined that the lone bidder submitted complete documentary requirements; thus, its bids were rated “*passed*”;

WHEREAS, upon evaluation by the Technical Working Group of the offer of the lone bidder, it was determined that the said bidder submitted complying offer; thus, its financial bid was opened on 10 September 2024 and the bid as read and calculated is as follows:

RESOLVED, as it is hereby resolved, to recommend to the Head of the Procuring Entity (HoPE) awarding the project: *Proposed Drilling of Old Lucban 2 Production Well* to **MACROTRADE RESOURCES INC.** in the amount of Nine Million One Hundred Fifty-Four Thousand and Five Hundred Ninety Pesos (Php9,154,590.00), inclusive of all government taxes, for being the lone calculated responsive bidder.
