RESOLUTION NO. 026-2025

**WHEREAS,** the Baguio Water District-Bids and Awards Committee (BWD-BAC), in accordance with the provisions of Republic Act (RA) No. 9184 and its Revised Implementing Rules and Regulations, conducted the bidding for the project: *Proposed Rehabilitation of Sofia De Vera Production Well*, with required scope of work and specifications under Solicitation No. 002-2025 (P) dated 18 February 2025;

**WHEREAS**, the approved budget cost for the contract (ABC) is Php9,499,776.16;

**WHEREAS,** only **LHS DRILLING ENTERPRISES** submitted its bids and during the opening of the technical bids (Envelope "A") on 10 March 2025, it was determined that the lone bidder submitted complete documentary requirements thus, its bids were rated "initially passed";

**WHEREAS**, upon evaluation by the Technical Working Group of the offer of the lone bidder, it was determined that the said bidder submitted complying offer thus, its financial bid was opened and the bid as read and calculated is as follows:
